COMMODORES LOG

The last day of summer has officially passed, and fall is upon us. The last club cruise of the season is October 1 and 2 to East Dock. Like many of you, we are soaking up the good weather and sailing memories for reflection on those long winter nights.

In late August, Steve Barrett sent me the 2006 Dredging Permit Application for signature and mailing. Although this did not need to be done until early next year, we wanted the new permit in place and ready to go for the 2006 dredging season. The Corps of Engineers has now come back with a request listing several items of additional information needed. Steve will clarify with the Corps just exactly what is necessary. This will undoubtedly result in the Board authorizing the expenditure of funds to secure data necessary to the permit application. More information will be available at the October general meeting.

As required by the By-laws [Article VI, Section 1(b)], Randy Webster recently completed a review of RCYC accounts and business practices. His report was presented to the Board on September 26 and a report will be made to the membership at the October general meeting. However, the Board chose to address one issue directly. Members have submitted requests for expense reimbursements to club accountants in many different ways. These range from the use of expense reimbursement envelopes to yellow sticky notes to almost indecipherable notes on crumpled, faded receipts. And, at times, expense reimbursement requests are made weeks or months after the event. Members who do not use the existing system for reimbursement create more work for the accountants, complicate filing and record keeping, and increase the chances for error in reimbursements and bookkeeping. Effective October 1, all expense reimbursements must be submitted using the expense reimbursement form/envelope. Requests for reimbursement must include original receipts and be submitted within 90 days of the expenditure/event. This form has been converted to a PDF file and may now be downloaded from the club's website. The

chair for a specific event or work party should make the submission for reimbursement for all expenses relating to that event/work party. Wes and Joyce have been instructed to return all requests that are not submitted with the proper documentation. Requests for reimbursement that lack the proper documentation or that are not submitted timely must be submitted to the Board for approval. Thank you, Randy, for a job well done. And, another thank you to Wes and Joyce for their services to the club. We hope we have made your job a little easier.

Calling all Girls! Calling all Girls!


Are you 15 to 17 years old? Then you'd better not let another month slip by without stepping up to represent Rose City Yacht Club during the 2006 boating season.

Moorage Matters

We still have room for another small boat in the moorage, and we are about to add to the waiting list for larger boats. On the dinghy front, I relocated a faded (deflated) inflatable dingly from the east end dingly dock to the west end float in order to create room for a heavy RIB. I have no idea whose little boat I moved, as there was no nameplate on the dock and no registration on the dinghy. Do put a nameplate where your dinghy lives; and, yes I understand that only motorized dinghies need registration numbers. Remember that Walk 1 folks must not store their small boat on either dinghy dock, since they already have room in front of their boat.

Finding room for everyone's boat will

occasionally require that I relocate a boat to better utilize slip spacing. This only seems to come up every other year or so, and such a move is not proposed without consulting with the Commodore first. The basic difficulty is that almost none of the slips on Walks 2 through 5 are any uniform size. This happened because the piling placement predated the installation of the newer headwalks and slips. Older members will note the irony that virtually all of our slips are now formatted wider than they were 15 years ago, reflecting the increased beam in production boats in recent decades. Having said that, many of our slips still need more width. The worst problem is on Walk 5. We have never completely "expanded" it after squeezing in extra boats during our Walk 1 crisis some years ago. This Loren Beach, Moorage Chair will be factored into the concrete upgrade on Walk 5 in a few years.

Who & Where - Note that the moorage layout with member name and boat name is posted on a board inside the hallway by the back door at the clubhouse. A large moorage layout diagram is posted on the board at the top of the ramps, per regulations from the Fire Marshall. Note that that board, with the plastic window over it, is reserved for "official" RCYC notices.

Winter is approaching. Please replace any frayed dock lines and broken snubbers, and renew any worn out chafing gear.

THANKS

A warm thank you to everyone at RCYC for the lovely gardenia plant and many well wishes from individual members of RCYC. I had open-heart surgery at St. Vincent Hospital on September 21, 2005, and am recovering nicely at home. The problem was progressive narrowing of the aortic valve over many years as a result of a congenital valve defect (a two-leaf rather than the normal three-leaf aortic valve), which reduced outflow from the left ventricle into my systemic circulation and also resulted in progressive ventricle hypertrophy (wall-thickening), and limited coronary artery disease. The solution was implantation of a bio-prosthetic three-leaf aortic valve made of metal, plastic, and valve leaflets from cow pericardium, plus a single sphenoid vein graft from my thigh (coronary artery bypass graft). The valve and graft are working well at present and I am ambulating well at home. The "moo jokes" are nearly endless, but much appreciated!! :-)
