# Commodore's Log

Fall has arrived, and so have the fall rains. October has been a busy month – the Old Salts' Dinner, two work parties, and new member orientation. On Monday, October 17, the Fire Marshal completed the annual test required for our standpipe system. My thanks to Tom Stringfield for attending to this matter.

Earlier this year, Steve Barrett and I agreed to start on the permit process for our dredging permit for the next five years beginning in 2006. Given the list of additional requirements we have received from the Corps of Engineers, this will be a long, involved and expensive process. As Steve reported to the membership at the October general meeting, the Corps is citing the Endangered Species Act and Magnuson-Stevens Act in requesting "additional" information. First, we need to complete a Biological Assessment. This item will cost us approximately \$7,100. Secondly, we need to prepare for review and approval of a plan for dredged sediment sampling and analysis. Plan preparation will cost us another \$1,100. The actual sampling and lab analysis/ reports could cost us another \$8-12,000. Steve also expects the Corps to require additional items. For example, he expects the Corps may probably require mitigation for dredging. If you recall, we were required to do some additional plantings and landscaping of the premises when we were given our headwalk permit. The final tally won't be known until we work our way through this process. And, we will probably face similar costs each time we renew the 5-year permit. With this

in mind, I have tasked the Long-Range Planning Committee with a review of our finances. I've also asked Dick Dyer to bring up the issue with CRYA. I have also passed along a summary to Tom Stringfield and asked him to raise the issue at the next WOO meeting. We'll keep you informed on the developments.

Also, at the general meeting I clarified the process for obtaining reimbursement of expenses incurred on behalf of the Club. The reimbursement envelopes are in a box in the top left side of the stereo/file cabinet, next to the reciprocals books. An Acrobat pdf file of the form has also been placed on the Club's website. Original receipts are required. However, it is not absolutely necessary that you use the form or the envelope provided your written summary of the expenses includes all the necessary documentation.

At the October Board meeting, Wes Davis reviewed the guarterly financial reports with the Board. Our line of credit should be paid off by the first quarter of 2006. Because of the unexpected and added expense of new piling for the breakwater, the Board had postponed ordering finger slips this year. With this in mind, the Board approved the purchase of four more 38-foot finger slips for spring installation. This is in keeping with our long-range plan to convert all wooden slips and walks to concrete. This purchase will leave us with about eight slips on Walks 2, 3 and 4 to be converted to concrete.

The Board also reviewed the final estimate for paving and installation of a new gate. The costs were significantly higher than expected. Therefore, the matter was tabled, pending completion of a financial review and recommendations from the Long-Range Planning Committee.

The Board will hold a special meeting on November 14 at 7:00 p.m. to set up the 2006 budget. The regular Board meeting will be held on November 28.

On the positive side, our Club continues to grow. We welcomed Jerry and Van Barnes and Steve Pipoly and Michelle Forrer as members in October. We will swear in another new member family at the November general meeting and have another candidate going through the membership process. See Marili's column for details. And another great social function is coming up -- the Walk 5 barbecue/auction on November 5.

# MOORAGE MATTERS

Congratulations to those who have upgraded their shore-power cords and made them safer and legal. If you are one of the few that still has an under-sized cable transitioned into a 30 amp adapter or plug, note that you must get this upgraded to a marine-quality cable rated for this amperage. This is a fire and safety issue, and is now part of the Moorage Rules. After a year of repeated notices, be aware that non-complying boats will be unplugged.

Kudos also to a recent work party that straightened out several warped slips. It looks like the concrete sections can shift a bit due to: 1) wake-caused waves, 2) through-bolts loosening, and 3) boats yanking on the end cleats. It is time to suggest that most boats on the outer half of each walk "criss-cross" their stern lines. (i.e. take the line to the opposite end-cleat on the dock). This gives more line length and room for a snubber, and reduces the vertical pull on the dock cleat.

Strong winter winds are coming. Are your fenders fully inflated and large enough for your boat? Check those mooring lines, too. You need nylon, preferably three-strand, with chafe guards -- make sure it is large enough without overwhelming your cleats. Note that sailmakers fund their 401K plans with repair and replacement of roller-furled head sails left up through winter storms. Tie your halyards away from masts, to pulpits or rails, to spare the residents the clatter and to protect your spar. It's time to check with the Billions to see if they still have your spare key with name and contact information on a tag.

Keep your boat well-ventilated and plan on winterizing the raw water side of the engine and also the potable water supply system. Do NOT depend on electricity to keep the interior above freezing -- the worst weeks of 20-degree weather ahead will usually also include several days of power outage along Marine Drive. "Been there, seen (and skidded on) that." I still have a photo of me standing on the frozen river by our boat, at RCYC, several years ago...


