## A View from the Rear

The return of east winds and rains remind us that fall is here. We did a fall foliage drive up the gorge to Hood River where we rode the Mt. Hood Railroad excursion train to Parkdale and back. The colors are spectacular. We probably won't have the opportunity to get much sailing in until early spring. Guess we will have to make do looking at sailing and sunset pictures from our Bald Eagle Cruise this summer. As I write this, the cruise schedule for 2007 has not yet been finalized. My poll indicated a dead heat between moving the dates of Lazy Days to coincide with Bald Eagle Days (the third weekend in July) or leaving the traditional schedule as is. The same dead heat prevailed on the question whether to have the potluck on Monday or Thursday. Regardless of when Lazy Days is scheduled, Mike and I (and at least two other boats) will be headed down river for Bald Eagle Days. Sailing, racing, and cruising your boat should be the first priority. If the dates work for you, great; if not, make your own sail plan and just do it!! Abraham Lincoln once said, "In the end, it's not the years in your life that count. It's the life in your years." And, what better way to put life in your years than spending time on your boat!

Over the last month, I have heard complaints from members about items disappearing from the galley and the refrigerator. With the holiday season approaching and several functions on the calendar over the next two months, a reminder may be in order. Food and condiments purchased by the Club are intended for Club functions, not to stock a member's boat or be used for private functions. Members who are working on their boats, dredging, or doing other projects at the Club may put a lunch or liquid refreshment in the refrigerator for their use later in the day. Often chairs for events such as a walk barbecue, etc., will inventory supplies on hand, purchase necessary supplies in advance and store them in the galley. It can be extremely frustrating to discover at the last minute that supplies on hand are no longer available for the event. Unless items in the refrigerator or on counters have an "eat me" or other sign indicating availability, please do not appropriate them for your use. And, if you put a lunch or other food in the refrigerator for later, make sure you use it or throw it out. The clubhouse stewards, committee chairs, or members hosting a private party shouldn't have to clean the refrigerator before using it.

Once you have winterized your boat and settled in at home for the winter, throw another log on the fire, curl up with a good book or revisit a favorite hobby. As you sip hot chocolate or tea, make plans for boat shows, sailing trips, and boat improvements. When 2007 begins, you'll be rested and eager to get the boat ready for another season of sailing.



### **Moorage Matters**

Work parties are winding down, temperatures are dropping, and dredging is starting up. I am hearing about some boats without snubbers or good quality bow and stern lines. Go out and check your lines for condition and chafe. Yes, you. Also, your mast must NOT line up exactly with the ones on either side of you. This will require some re-tying of your mooring lines. We seem to average about one idiot-boater-tsunami through the moorage per month. Of course it's not just us; all the marinas with any exposure to channel traffic have the same problem.

I am presently assigning new boats to two slips where members have vacated. The waiting list is about to zero out, so if you know of someone that might want to apply, do encourage them. Just be sure to emphasize that we are seeking additional active participating members, and that low-cost moorage should not be a primary reason for wanting in. But, you knew that already.

Coming or going from the moorage, you might want to know the present (real-time measured) river level. Cut and paste this URL for this info.

## NEWS From BoatUS: What You Need To Know About E-10 Ethanol Fuel And Winter Boat Lay Up

This spring and with little prior notice, recreational boaters in most parts of the country were introduced to gasoline containing higher concentrations of ethanol, a corn-based additive that replaced a known carcinogen, MTBE. The new fuel, dubbed "E-10" for its 10% ethanol content, unfortunately has the ability to attract greater amounts of water and "phase separate," or form two separate solutions in the gas tank, usually over a long period of time. Once this happens, the engine won't run and internal damage could occur.

With the lengthy winter lay up period upon us, many boaters are asking how they should store their boat over the winter to prevent fuel problems next year. The BoatUS damage prevention newsletter, Seaworthy, tackles the problem in its October issue and has these recommendations:

- Once phase separation occurs in E-10 gasoline, additives and water separators cannot help. The only remedy is to have the gas and ethanol/water professionally removed from the tank.
- With any fuel that sits in a tank for a long time, it's important to add a stabilizer. But understand that stabilizers do not prevent phase separation.
- E-10 has been a fact of life in certain areas of the Midwest for over a decade and there have been relatively few problems. The best practical recommendation learned from marina operators in the region is to top off a boat's fuel tanks to about 95% full, leaving room for expansion. A tank that is almost full limits the flow of air into and out of the vent, which reduces the chance of condensation, adding water to the fuel. Draining the fuel tanks of E-10 gas, while completely eliminating any chances of phase separation, is a potentially dangerous and an impractical solution.
- Whether you believe your boat's fuel tanks are half full or half empty, leaving a tank partially filled is a bad move. A Midwest marina owner confirmed that phase separation problems typically occurred when boats were stored over the winter with tanks only one quarter to one-half full. In the summer, infrequently used boats with partially filled tanks are also prone to phase separation.
- Never try to plug up a fuel tank vent to prevent moist air from entering a tank. Without room to expand, the additional pressure could rupture fuel system components.

## **RCYC 75th Anniversary Logo Contest**

In 2007, RCYC will celebrate its 75th Anniversary, and we want to be prepared to celebrate in style. A special logo will help us recognize this accomplishment, so we are calling on our members to submit designs. Here's what you need to know to enter your design:

What will it be used for: Winning artwork may be used on T-shirts and other apparel, club stationery, Foghorn masthead, yearbook cover, brochures, and programs used during 2007, and member name badges, as well as other items.

How should it look: The design must be adaptable to both color and black-and-white and for large and small items. Color designs should be executed in the club's red, white, and blue color scheme. An optional fourth color may be added for accent.

Who can submit: Any RCYC member or their immediate families. One entry per artist.

**Judging**: The unsigned and unidentified color versions will be available for viewing at the December 20, 2006, General Meeting. Judging will be "blind" in that only the chief judge will know who submitted which piece. A panel of RCYC judges will be selected from among non-contestants and will vote on or after the December 20 general meeting. The winner will be notified by e-mail and announced at the January I "Soup and Sail" and in the January Foghorn. All contestants will be recognized in the Foghorn. The winning original artwork will be framed for display in the Clubhouse during 2007.

**Submission Guidelines:** Artwork must be the artist's original design. Good quality photocopies are acceptable. Submit the following on  $8-1/2 \times 11$ -inch heavy stock white paper:

- one black-and-white copy with the artist's printed name and signature in the bottom right corner,
- 2) one unsigned black and white copy,
- 3) one unsigned, color copy, and
- one unsigned color copy Xerox-reduced to 2 inches (width or height) to demonstrate adaptability to small sizes.

**Give us your name:** Include with your artwork a 3x5 card listing the *artist's* full name, telephone number, address, and e-mail address, and the *member's* full name, telephone number, address, and e-mail address, (i.e., if the artist is the offspring of a member).

**Deadline:** Submit entries unfolded to the address below so that they are *received by* **December 15, 2006.** If the deadline is missed or any of the above components is missing, the submission may not be considered.
