See you on the water.

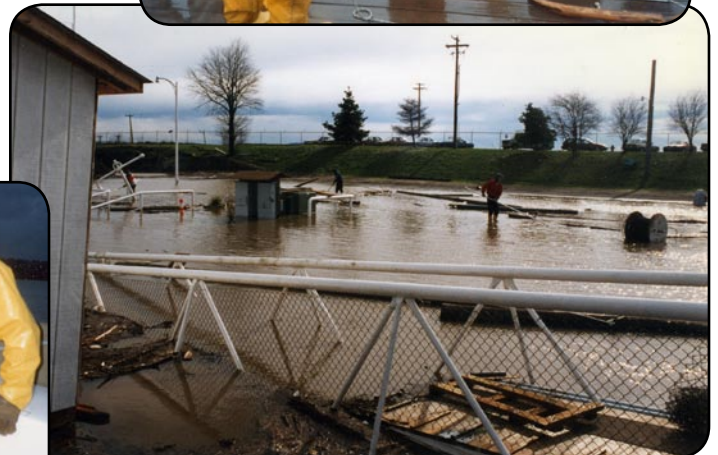

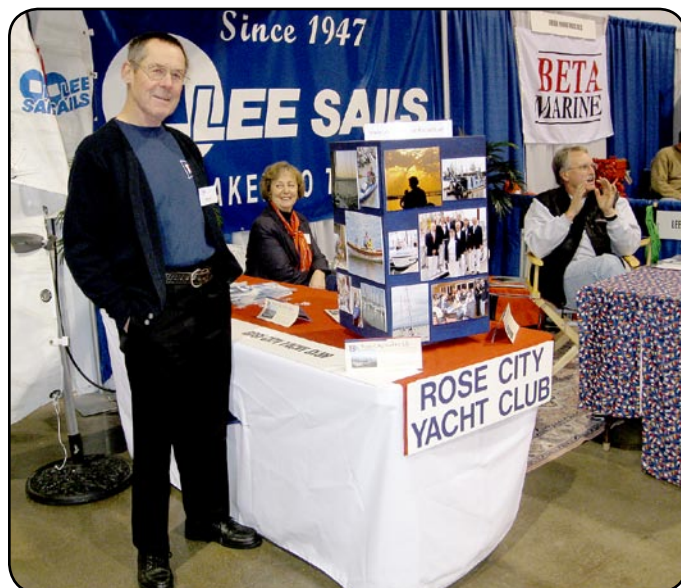
Vice Commodore's Report

Many thanks to Jim Douglass for the initial work on the RCYC 2008 Club Calendar. It is posted on the RCYC website, and the current month and next month will be posted on the board at the back of the Clubhouse. I will try to be prompt in updating it as soon as new reservations are made. The reservation form is also posted on the website, and I will make sure some are available at the Clubhouse.

There is a change to work hour requirements. Work hours must be completed by June 10 for the first half of the year and completed by December 10 for the second half of the year. This change will allow time to report billing information to the bookkeepers, and for them to prepare the next quarter's bills which are mailed before the end of the quarter. Work hours done outside of scheduled work parties need to be coordinated with the Work Party Chair. Contact the Board if you are unable to fulfill your obligation for some reason such as health.

The position of **Work Party Chair is still vacant**, and we are hoping someone will step up to fill it. The position is primarily responsible for scheduling and prioritizing maintenance tasks, and to have chores identified for those people unable to make a scheduled work party. There is a list of periodic maintenance that needs to be done, and Club officers will do a walk through the moorage with you to identify other problems that need attention. **Please consider filling this important Club position. We need your help.**

DINGHY STORAGE AT RCYC

The requirements for labeling and storing dinghies at RCYC have been mentioned regularly in the Foghorn. Since dock space is increasingly at a premium, on January 16 I took an inventory of the small boats on the dinghy docks as noted on the list below. Some members' boats may be stored away from the Club for the winter, but I noted the name label on the dock space where there was one.

The "???" on the list indicates a space with no name label and/or a dinghy with no identification. Some of the older dinghies are believed to be unused or unclaimed for as much as a decade. Newer, active members want to store their boats on these docks, and deserve an opportunity to do so. Anyone owning one of the mystery (??) dinghies should get a weatherproof name label attached to their spot soon, by the end of April at the very latest.

If you are not using your small boat, please take it home soon and stop storing it at the Club. When you do this, please let me know which spot is open. If you no longer want the boat, you still need to identify it and let me know that it is for sale, and then plan on removing it by the end of April.

With the backing of the Board, unidentified ("abandoned") dinghies will be moved up by the west storage building sometime after May 1, and their dock place will be given to an applying member. The Board will then decide on disposition of any unclaimed dinghies.

Since there are no "slip numbers" for dinghies, I have identified the locations, reading from East to West. If I have missed anyone's label, I apologize. Just call or e-mail me and let me know.

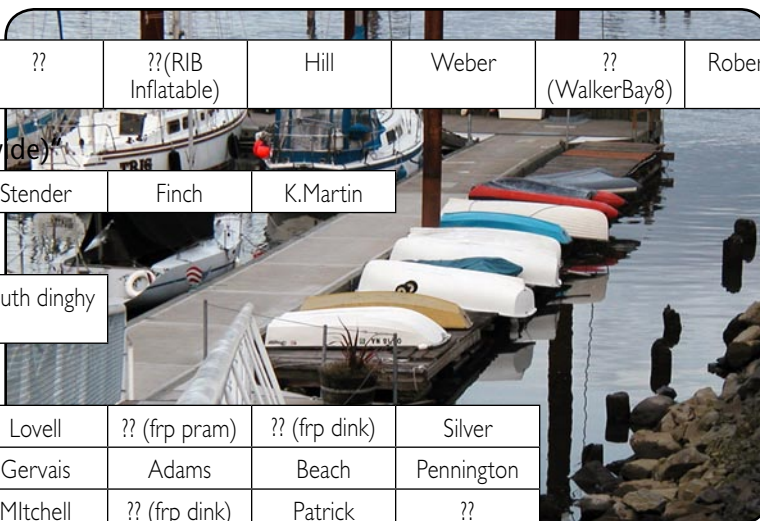

Dredging News

On January 14 the last of the sand was pumped into the holding pond for the dredging season. The dredgers were very busy this year, removing an estimated 4000 cubic yards of sand from the moorage. The fairways of Walks 3 and 4 were dug to -7 ft. Columbia River Datum (CRD) for the first time in recent memory. Walk 1 saw a couple of humps removed and some slips dredged. Walk 5 fairway was again dredged to -7 CRD. Over 30 of your fellow Club members spent over 70 days crewing the dredge or taking turbidity readings, tallying over 1000 person-hours in the process. A big "Thank You!" to all participants, and thanks to all for your patience in having your boat confined by, or having to step over, pipes.

Several new members and new-to-dredging members volunteered this year. We now have a dredge operator contingent of about 10 members with several years experience. Another 20 members are experienced helpers, or took turbidity readings, or kept the dredge fueled and lubed or helped move dredge pipe, a few boats, and the dredge. Several members who have "day jobs" gave up part of their weekends to work on the dredge crews.

We had no significant breakdowns this year, and removed the sand in record time. It's a great program with so many eager men and women helping out. A big thanks to all. Newcomers are welcome, so for a great time, think about volunteering next fall.

Two Federal Tax Deductions Remain For Boaters

When Congress adjourned for 2007, they left in place two federal income tax deductions of potential benefit to boat owners.

A boat is treated like a second home for federal tax purposes if it has a galley, a head, and sleeping berth. Mortgage interest paid on the loan is deductible from your federal income taxes. Taxpayers may use the mortgage interest deduction for one primary home and one second home and must itemize deductions on their returns.

Some boaters may be unaware of this potential tax benefit because not all lending institutions send borrowers an Internal Revenue Service form 1098 which reports the interest paid. Not receiving the form does not preclude taking the deduction. If a 1098 is not available, boaters should contact their lender for the amount of interest paid and should enter it on line 11 on Schedule A along with the lender's tax ID number. If a form 1098 is sent, boaters should simply enter the amount on line 10 of Schedule A.

The other tax benefit is a deduction for state sales taxes. However, this may no longer be available after the 2007 tax year if Congress does not act to extend it. This deduction may be appropriate for boaters who paid substantial sales tax on the purchase of a new or used vessel last year. Boaters must choose either the state sales tax deduction or state income tax deduction on their federal tax return — you cannot take both.

In addition, to take the sales tax deduction, the sales tax on a boat purchase must be applied at the same tax rate as the state's general sales tax. In order to claim the sales tax deduction, tax returns must be itemized. State sales taxes are entered on Schedule A, line 5b.

For those who fall under the Alternative Minimum Tax, most deductions are unavailable as taxes are calculated differently. Boaters are urged to contact a tax preparer or financial advisor for more information.

View from the Rear

Have you ever wondered about the items displayed on the RCYC "Awards Wall"? The plaques and burgees displayed on the north wall of the Clubhouse include both perpetual awards and some one-time honors. I've highlighted three of those items below and will talk about the others in a future article.

One of the plaques displayed is a list of First Mates Presidents. The First Mates organization was made up of the wives of members (back before we recognized both spouses as "members") and they took on the responsibility of planning many of the Club activities and events. These were often fund-raisers and included annual parties such as the Shipwreck Dance, a Halloween Party and a New Year's Eve Party. They also put on ladies luncheons and fashion shows, and a wiener roast on the night before the Pirate's Breakfast. Proceeds from their fund-raising events were used to buy the original galley stoves, plates and silverware, and other furnishings for the Clubhouse. Our square tables and the chairs we recently replaced were one of the last purchases made by the First Mates, which disbanded in 1985.

Life Members were originally recognized on a plaque similar to the First Mates' plaque. Can you imagine how many additional pieces would have been needed to recognize all the people on the list we currently display? The current list is truly a "living" document, and we add names to it whenever a member is approved for life membership. Are you qualified to become a life member? Check out the Bylaws at the back of the yearbook. If you are 65 or older and have 20 consecutive years of active membership, contact the Board to request a change to Life Member status.

The Golden Hammer Award was instituted in 1990 and recognizes a member who has made a valuable contribution to the Club's success in the past year, or who has made a sustained contribution in a particular area over a period of years. The selection of the recipient is traditionally made by the outgoing commodore and is kept secret until the award is made at the Commodore's Ball. Although the selection is usually based upon some kind of "physical" work, it can also be awarded for administrative contributions. If you are curious about who will receive it this year, come to the Commodore's Ball!



RCYC Gate Update

The RCYC gate has been fitted with an electronic gate opening device (similar to a garage door opener). When activated by an opener, the device essentially turns the key in the lock allowing the gate to open. This was done to allow trucks to enter the Club more easily by activating the gate opener while waiting to turn across traffic into the Club, thus reducing damage to our gates and eliminating a traffic hazard. It works so well, the Board has decided to make the devices available to Club members if sufficient interest in a purchase exists.

The Board proposes to allow members to purchase up to two devices per membership. Cost will be between \$25 and \$30, depending upon the number of members who wish to purchase such devices. Payment must be made in advance of purchase and delivery of the opener. Each device purchased will be programmed to access our gate. The devices are all numbered and will be tracked similar to the way we track gate keys. A member who resigns has the option of returning the gate opening device to the Club, provided it is in good working condition, and receiving a refund of the purchase price. If a member leaves the Club and does not turn in the gate opening device, the number can be deleted from the controller, making the device inoperable. Thus, security issues have also been addressed.

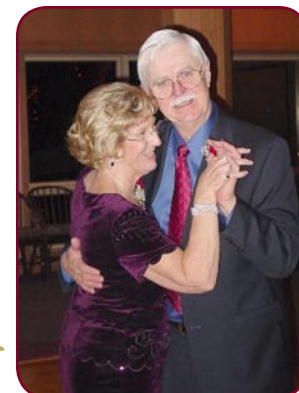
