Five Ways to Cut Your Boating Bill This Summer

Despite how boating is portrayed in Hollywood movies, most boaters are not rich. Statistics show they are more likely to own a small trailerable boat than a mega-yacht, and prefer T-shirts and shorts over blue blazers. They also watch how they spend, and to help boating families stretch their dollars, BoatUS has five ways to save on boating expenses this summer:

Borrow a kid's life jacket for free: If you're expecting young guests aboard and have a temporary need for a right-sized life jacket, don't buy one. You do not have to be a BoatUS member to use this program. RCYC has a bin at the top of the ramp full of loaner life jackets of different sizes.

Take a boater safety course free of charge: Boating safety courses can set you back almost \$45 if taken online, or as much as \$100 for a classroom-based course. Or, you can take the BoatUS Foundation's free Online Boating Safety Course which is recognized as boater certification in 32 states. BoatUS membership is not required.

Join BoatUS and save at marinas on fuel, overnight slips and repairs: Save money on fuel by getting up to 10 cents per-gallon off at select <u>BoatUS Cooperating Marinas</u> http://ww2.boatus.com/marinas. Other discounts may include up to 25% on transient slips and 15% on repairs. As a cooperative group, RCYC members can join BoatUS at the half price rate of \$12.50 per year. Get discounts on bait, tackle and guides: BoatUS members can also get discounts of up 20% at bait and tackle shops as well as up to 30% off fishing guide services. Go to http://ww2.boatusangler.com/ BoatUS Angler to check them out.

Try adjusting your boat insurance: Increasing your deductibles will save you some dollars. If you have had your boat for a period of time, consider reviewing the total value of your policy with your agent; even consider purchasing a liability-only insurance policy thus saving premium dollars. You can also investigate some lower-cost options with BoatUS Marine Insurance "http://www.boatus.com/insurance".

Moorage Matters

We are presently filling one opening, but the waiting list will still have five boats on it.

As the river traffic picks up for the high season, be aware of where your spreaders and mast head lines up with the rig on the boats on either side. There was recently a broken masthead fitting from another boat's rig due to a big wake. Also, be sure to have snubbers on bow and stern lines. All your mooring lines should be good quality nylon -- you want both strength and stretch for that application.

Due to requests by several members (yes, really ...) we are starting up the weekly "take your boat out or crew on another boat" night, on Tuesdays at 6:00 PM. Check in at the Clubhouse and gather up members for crewing or go out with another member. Let's start on June 1, and continue on until DST ends this fall. This is very informal. I would only suggest bringing your pfd and a snack if you are hungry. Dress for the weather. If you schlep along an extra can of pop or other beverage to share, that might be good, too. You can meet other members and share some boating time with them. There are a lot of different boats here, and I sure have enjoyed sailing on other members' boats last year. Cruising Boaters Could Find Tax Bills Under the Welcome Mat Revenue-Hungry States Go After Visiting Boaters

ALEXANDRIA, Va., May 5, 2010 - Staying too long in one place can ruin a good thing At least that's the case with boaters making lengthy journeys, who are finding themselves targets of cash-hungry states looking to balance their budgets.

In most states, a privately owned recreational boat must be registered in the state where it is principally used, and any taxes are paid to that state. A problem arises when the boat leaves this principal-use state and enters a new one, either for a long visit, extended cruise or lengthy repairs.

Boat Owners Association of The United States (BoatUS) says boaters may be subject to various sales, use, excise, or property taxes when they remain in one location for a consecutive number of days, or over-stay their visit for a certain number of aggregate days per year. This "grace period" is often 60 to 90 days but as little as 30 days in two states (CO, NH). Also, if the principal state's tax is not comparable to the tax in the state the boat is visiting, the second state can levy the tax making the boat owner liable for the difference.

To help boaters understand this issue, BoatUS offers a new online map highlighting state sales and property tax rates with links to state tax departments, as well as registration information and "grace periods" at http://www.BoatUS.com/gov/StatetaxRegistration.asp.

In several recent cases, BoatUS reports tax authorities walking the docks, inspecting marina records and aggressively enforcing tax codes. "States are strapped for money, and they are increasingly looking at these visiting boats," said BoatUS Vice President of Government Affairs, Margaret Podlich. "We urge cruising boaters to be aware of potential tax liabilities when traveling, plan accordingly, and be ready with documentation in case disagreements arise with tax authorities," she added.

"We believe boaters should pay their fair share of taxes," Podlich continued. "However, our concern is that some boaters are being unfairly targeted for this tax levy. Some tax agencies have made it difficult to dispute the tax, even with accurate owner recordkeeping such as log entries, marina and fuel receipts or repair contracts. These documents are critical for boaters to keep, and are often the only way to fight an unjust tax bill," said Podlich.
