Shock prevention class & boat testing

Stray currents not only accelerate corrosion of metal parts but can prove fatal to those on the boat or in the water near a boat with this problem. Our waiting list for new member boats is now at seven, and soon will be at nine. The moorage is very full. Repeatedly, I and the membership chair are asked about when some turnover might create a moorage vacancy. This would let an active new member family bring their boat into the moorage and allow them to participate more directly in club activities.

Any prospective members should expect a wait of at least a year for a slip of their own. Anyone wanting their own PDF copy of the moorage lists posted on the club's cork board can email me and I will send one out.

Temporary slips are another matter, as the club's moorage rules permit the club to sublet a temporarily-unused slip and credit the slip rent back to the assigned member.

By May, we should start seeing openings around the moorage, usually on walks 1, 2, or 5, where boats have gone North for two to four months on vacation. I always ask those members planning on vacation cruises to let me know when they are leaving and planning to return. Anyone on the waiting list wanting a temporary "double fill" slip for the summer should let me know. If you cannot reach me, just contact the Port Captain or Residents.

Spring is here and longer days bring more security concerns. Whether by land or water, sometimes the club has "visitors" who are looking for a lot more than an unauthorized dock walk. Keep the slide gate closed in our parking lot when it's not monitored during a social event. At dusk, lock up all clubhouse doors and close the ramp gate.

We have important rules for "invited" guests also -- like requiring that all kids under 13 must wear a PFD on the docks and walkways. All visitors must be

Financial Matters

Over the last two quarters, we have seen a significant increase in late payments. Maybe people have had too much fun skiing or have headed south in search of sunshine. Maybe it's due to the sluggish economy. Regardless of the reason, the matter needs to be addressed.

Please read Article IV, Sections I and 2. Members have an obligation to pay their quarterly billing within 30 days of the billing date. "Any account not paid in full within 30 days of the billing date shall become delinquent. Delinquent accounts shall be assessed a late charge of 10% for each billing period that a delinquency exists."

This means that your check should be at the bookkeeping office no later than the end of the month. If the last day of the month falls on Saturday or Sunday, the check should be there no later than the following Monday. This does not mean that the check is written on the last day of the month or mailed on the last day of the month. If the check is not timely received, the bookkeeping service has instructions to send out a second billing with a late fee assessed.

THE BOOKKEEPING SERVICE DOES NOT HAVE THE AUTHORITY TO WAIVE ANY LATE FEE. If you are assessed a late fee and feel that due to extenuating circumstances it should not have been applied, please contact Judy Oxborrow via e-mail judy87807@comcast.net or by telephone (503) 652-1549 to discuss your situation. If your payment crossed in the mail with the second billing, you still owe the late fee. You would not have to submit a second payment as it will be added to your billing for the next quarter. If you are going to protest a late fee, please do so timely. The assessment will be considered final on the last day of the month in which the following quarter's billing is payable. For example,

you are billed April I for the April through June quarter. If your payment is not received by April 30, you would be sent a second billing with a late fee added. You would have until October 31 (date third quarter billing is due) to protest that late fee.

YEARBOOKS – The 2011 yearbook is being printed. It will be available for pickup during the April 20 general meeting. If you cannot pick up your yearbook at that time, you will find them in tubs in an envelope with your name on it in the clubhouse. Please take the entire envelope with you. If you have a boat in the moorage, you will be expected to pick up your yearbooks at the Clubhouse. They will not be mailed to you. Inactive and inactive life members will receive a copy of the yearbook in the mail.

So here is the simple challenge to all walks: Get your free **V**essel **S**afety **C**heck before Opening Day. The walk with the highest percentage of boats that have their **VSC** stickers displayed by noon on Friday, May 6 will be the winner.

Getting the **VSC** sticker is easy, just make a **V**ery **S**imple **C**ontact with our own U.S. Coast Guard Auxiliary Inspector Lynn Easton to schedule a time. Lynn is setting up the inspection schedule for most weekends in April, but the easiest times will be during the two work parties, April 2 and 16. Look for the schedule posted on the cabinet near the front door of the club house. Lynn will also do weekday inspections with prior notice.

Last year I had everything ready for Lynn's inspection. Easy access to all areas of the boat and items from the list displayed in the main cabin. Before Lynn even got on the boat his first words

were, "Where is your bow running light?" No matter how many times I had recently walked past the bow I had not noticed the broken light! It is so easy to take for granted that all is well on my carefully maintained boat. Lynn's observant eyes really helped. Who knows what near disaster he saved me from!

Check your boat and inventory of required safety equipment and be prepared to sign up for an inspection in April.

What Is A Vessel Safety Check?

The Vessel Safety Check is a complimentary check of your boat conducted by members of the Auxiliary, confirming that it meets both federal and state requirements for safety. No citations are issued and the results of the safety check are not reported to any enforcement agency, but a decal is awarded to display if the vessel has passed the examination.

The Vessel Safety Check gives you a riskfree way to check that you meet the legal minimums and to potentially avoid a citation later.

The Vessel Safety Check (VSC) is performed at your boat – whether in a slip, at the launch ramp, or in your driveway – by a certified Vessel Examiner, at a mutually-convenient time, and usually takes 30 to 45 minutes, depending upon the size of your boat.

What Type of Items Are Checked?

- I Life Jackets
- 2 Registration and numbering
- 3 Navigation lights
- 4 Ventilation
- 5 Fire extinguishers
- 6 Distress signals (flares, horn, etc.)
- 7 Battery cover and connections

All of these items are currently required by state and federal laws and, if missing or non-operating, can result in a citation if your vessel is inspected by the Coast Guard.
