## Commodore's Log Ethan VanMatre, Commodore

November is upon us, and with it come winter's gales, high winds and heavy rains. In the winter months, I try to get down to the moorage at least once a week. I'm looking for chafe on my dock lines and canvas, as well as searching out any deck leaks that may have cropped up. I check the bilge and make sure that the cockpit drains are open. It is interesting and instructive to look at the way your boat moves in its slip during a blow. For long life, I change my engine's oil. Acids build up in oil when we run our engines. By changing oil we can remove those acids and reduce internal corrosion as our engines sleep this winter.

By now, the piling and waterline projects will be completed or nearly so. All those boats that were displaced are back in their slips. I am always amazed by the amount of work that is done by our members. The big projects are usually taken on by our seasoned members but I would like to point out that those members were, once-upon-a-time, new members, not quite knowing what was needed to be done or how to do it. As a "do it yourself" Club all that is needed is to say "I can help".

#### RCYC Moorage Rules and By-Law Changes

This information was first printed in the September Foghorn. However, we will be voting on the By-Laws change at the November general meeting, so the information is being reprinted.

Below are proposed changes, approved by the Board, for both the Moorage Rules and By-Laws. The actual changes are highlighted in bold. The moorage rule change addresses safety issues. The By-Laws change addresses the issue of bonds held by Inactive Life Members.

The Finance Committee and the Board feels morally and ethically obligated to refund the bonds for all persons no longer members of the Club. In the case of Inactive Life Members, especially those who choose to remain members, but move and maintain little social contact with the Club, this has proven to be a major challenge. Often we do not learn of their passing for months or years. Inactive Life Members have no financial obligations to the Club. With this change, Inactive Life Members could still remain as members but would have the option of requesting their bond be refunded now. This would help reduce the number of cases where we are dealing with outstanding bonds. The By-Laws change will be voted on at the annual meeting.

Moorage Rule Change

Section F. Safety and Security. Replace in its entirety with the following:

- 1. The entrance gate to the parking lot is to be locked at all times unless it is attended. The gate at the top of the ramp descending into the moorage and Clubhouse is to be locked from dusk to dawn. Any member leaving the Club grounds during this period should secure the gate behind him/her unless there is a sponsored event in the Clubhouse.
- 2. Children ages 12 and under shall wear a life jacket while on docks or on the patio.
- 3. As a precaution against any stray electrical current, there shall be no recreational swimming within the moorage.
- 4. Persons working on the bottom of their boat or having a diver provide these services should exercise caution.
- 5. Violation of security and/or safety rules should be reported to a Flag Officer for action by the Board in accordance with Article XIX of the By-Laws.

By-Laws Change

Article II. Membership, Section 5. Inactive Life Member – Change to read:

Any Life Members who sell their boat or permanently move it more than 50 miles from the Club's moorage and still wish to retain an affiliation with the Club may apply for Inactive Life Status. Inactive Life Members shall pay no fees. **Upon being granted Inactive Life Member status and having no further financial obligation to the Club, a member may surrender his/her membership bond for refund.**

#### **Construction Update**

<u>Walk 3 Waterline Replacement:</u> Chuck Pennington and his crew will receive their piping materials on Monday (October 20) and will get to work right away. With some luck and help from the weather gods, the work should be nearing completion by the end of that week. For any waterline work remaining to be done in the following week, Chuck may need to arm-wrestle with the piledriving crane for working room on Walk 3. It won't be a fair contest, and Chuck will finish up as soon as he can. Thank Chuck and his crew for their efforts when you see them.

<u>Walks 2 and 3 Shorepower/Lighting Work:</u> As of October 9, all of the new shorepower boxes and lights on Walks 2 and 3 have been installed and powered up. Our goal was to have the work completed before the overhead lights came down in preparation for piledriving on these walks. With many hours of hard work by Ron and Karen Billion, our Electric Works electrician Steve Bergstrom, and Karl Quade and Bob Gales, we were done with time to spare. Our final inspection should happen soon. When you see Ron, Karen, Karl and Bob, please give them a big thank-you.

As I mentioned in an email last week, the new shorepower boxes are equipped with GFI breakers, which will help protect anyone in the water but are very unforgiving of even minor faults in a boat's wiring system. When GFI breakers were installed on Walk 5 last spring, three boats experienced constant tripping of their GFI breakers. For at least 2 of those boats, the tripping was a symptom of wiring problems in the boat. When the wiring problems were located and fixed, the tripping ended. So if your boat is on Walk 2 or 3 and your new GFI breaker will not hold, the first thing to do is carefully inspect (or have an experienced marine electrician inspect) your electrical system to look for problems. Alison Mazon is a marine electrical wizard and could offer help if you are having problems.

<u>Walks 2 and 3 Piledriving:</u> Piledriving work is scheduled to start during the week of October 27 - on October 27<sup>th</sup> itself if the contractor's current project finishes without problems. The work should take 3 or 4 days to complete. Getting ready for the work has been a real nuisance for those with boats on Walk 2, many of whom have had to find a new home for a week or two in order to let us remove several fingers for crane barge access and to be away from the wood piles when the piledriver removes them.

Loren Beach has been coordinating all of these moves with the patience of a saint. We have moved the goalposts on

him several times by making last-minute changes to the boat move list and he has taken this in stride. Thanks Loren. Ron Moran and Ron Billion (What will we do when Ron and Karen move "to the dirt"?) have generously agreed to fill in for me for the remainder of the piledriving project, while Vickie and I vacation in SE Asia. We'll be leaving just before piledriving is scheduled to start. Good planning or bad planning, depending on your point of view. I am in Ron and Ron's debt. Twenty or so RCYC members have also vol-

unteered to help with the project. We will recognize their efforts in the next Foghorn.

RCYC Sidewalk Superintendents are welcome to come down to the Club to watch the work. The big crane barge and its crane put on a good show, but please stay off Walks 2 and 3 while the work is under way. An accident would spoil everyone's day.





#### DREDGE TRAINING RCYC CLUBHOUSE Saturday, Nov 1—9:00am

The season is upon us and since most of us old timers have trouble remembering which is port and which is starboard, Jim Calnon has kindly agreed to teach a refresher dredge class. He will begin promptly at 0900 (that's nine o'clock in the morning!) on Saturday, November 1st in the RCYC Clubhouse.

Anyone who is new to dredging, or wants to move up from helper to operator, or needs a little refresh, or just needs something to do on Saturday morning is invited to attend. Jim has lots of experience dredging and wants to impart his tremendous knowledge on the subject to all of the rest of us. I hope to see you there!

We have several new members waiting to move into slips, and about six boats on the waiting list. Note that no open slips will be filled until after the piling replacement project is done. At press time, the crane barge move-in is scheduled for Oct 27, and the work should take about three or four days.

A lot of Walk 2 boats are temporarily parked all around the moorage and members on several walks will be blocked in until the piling work is done. Besides moving the boats that would be directly impacted by pile driving, the three end slips on Walk 2 (and all the boats tied to them) have to be removed to allow the barge to get around the corner. On the plus side, it will be great to have the last of the old wood pilings replaced with steel.

Once the crane leaves, the finger docks at the end of Walk 2 will be returned and bolted up and all of the displaced boats can go home. In the best spirit of RCYC, members who are at the moorage to move their boats, have been generously helping others do the same. As the boats get back to their home slips, do check on your dock lines, snubbers, and chafe gear.

### Rose City Youth Sailing Society By Pam Sesar



#### **Nautical Reads**




Over the years, lots of boating stories have been written. This is good because I enjoy reading about adventurous voyages and exciting ports. I like having a wide choice of what to read, and this month I have decided to return to the original boating story. "The Odyssey" by Homer, written in 800 BCE, tells the story of Odysseus as he returns, after the Trojan War, to his home in Ithaca.

As often happens when voyaging, the return trip takes longer than planned and Odysseus encounters fair winds, storms, beautiful women, exotic ports, a few unpleasant giants, and of course shipwreck and tragedy. It is a story that has been enjoyed for three thousand years. The Odyssey has been translated many times, both in verse and prose. A good modern verse translation is the one done by Robert Fagles and published by Penguin Books. It is understandable and captures the pace and form of the original Greek.

One well known sailing couple that came under the spell of The Odyssey were Hal and Margaret Roth. They retraced Odysseus' path in their 35' sailboat and wrote "We Followed Odysseus" about their trip. They sailed to the places on which Homer based his story, and were able to see and experience what those places are like today.

Both of these are great books to read by the fire on a winter's night. If you need encouragement to tackle Homer, read the Roths' book first. Otherwise, dive in with Homer and have a classic experience.



#### If you go:

If arriving at Barkley Sound directly from the US, you must go to Ucluelet for Customs check-in. Ucluelet is a fun stop, too, and the Co-op is a good place to reprovision.

Bamfield Inlet splits the town into east and west sides. An unimproved road connects the east side to Port Alberni. There is no road access to the west side.

In Bamfield there are public docks on both sides of the inlet, a few marinas and room to anchor. Hot showers are available at the park facility just up the road on the east side. There are two small well-stocked grocery stores (one on each side) and a couple of cafes. Fuel, water, garbage disposal, and WiFi are available.

#### Winterizing Your Boat

Marine Surveyor Pat Devlin gave a presentation at the October 15, 2014 General Meeting. Pat is an A.M.S.® with the Society of Accredited Marine Surveyors and an associate of Alison Mazon, A.M.S.®, a member of RCYC. Pat talked about preparing one's boat for winter weather on the assumption the boat will not be used during the wintertime.

First, the boat's fresh water system needs to be drained and filled with RV anti-freeze. The water heater should also be drained; the 110 volt AC connection should be turned off and faucets should be left open. If the head utilizes a manual pump, dish soap makes a good lubricant and winter preparation is a good time to lubricate it.

For boats with inboards, the engine's fresh water cooling system should be drained and filled with new anti-freeze. Drain the engine's raw water system and close the cooling water seacock. RV coolant can be used to protect the engine's raw water system. Winterizing is a good time to perform regular engine maintenance, such as adding a stabilizer to the fuel, and inspecting and replacing belts, hoses, filters, and the raw water pump impeller. This is also a good time to check engine mount tightness.

With an outboard, any fuel left in the tank should be drained. Add fuel stabilizer to any fuel left over the winter. This is also a good time to replace fluids, drain the carburetor and disconnect the fuel hose. Pat stresses that only marine gasoline (without ethanol) should be used in outboards. He also stressed that cockpit drains should be checked for blockages. Using the dock hose water and forcing water through them is one way to clean the passages (before dock water is shut off until spring).

Pat also addressed the use of Extreme Heat 110 volt AC heaters, stating that they do not replace the need for ventilation on a boat to prevent moisture buildup and condensation, and that shore power should never be relied on for freeze protection. Removal of any unnecessary items, cushions and equipment is key to keeping the vessel uncluttered.




