Unfinished Business

- Barbara Weiss and CJ Volesky propose deactivating the gate exit pressure pad and install an exit gate that would be activated with a keypad sensor similar to what we have on the entrance side. The exit gate would exactly model the entrance gate functionality, With the activation post on the driver's side of the exit and a similar distance from the gate as our current entrance key pad. We would need to put up signage for entry and entrance directions. Primary considerations would be to insure that trucks have easy ingress and egress. Barbara and CJ will be gathering cost information to bring to the Board. Plans and options submitted.
- Ben Thomas shared Sign designs for outside the Club fence.

- First idea Stainless steel letters, three feet tall that are stored in the chapel. The backing would be 4'x10' made of 1"x3" IPE boards, finished with a penafin rosewood finish, supported by 6x6 posts, struts and cement base. Will include flood or other lighting. Using this sign design, there are three options. Ben recommends option number two:
 - 1. Single side facing marine Drive (existing sign location)
 - 2. Double side facing east-west (same location).
 - 3. Two identical signs, one on each side of entry; one facing east and one facing west

Ben recommends cutting a large, lateral tree branch that is blocking visibility from the sign area. Plans submitted.

Second idea - Entry gate sign. Not in consideration at this point.

New Business

• Loren Beach moved that we amend Clubhouse Rental Policy to read: 8. Security and Safety - All gates are to be left closed at all times and specific event codes issued and used. If the gate code pads are inoperative then the host/sponsor of the event is to appoint a gate monitor to closely monitor the drive through gate. During that time the ramp gate may remain open ONLY as long as the entrance gate is closely monitored. The entrance gate and the ramp gate are to be closed and locked when the gate monitor retires to the event. All gates and clubhouse doors and windows shall also be secured immediately after the end of the event.

Barbara Weiss seconded the motion. Passed unanimously.

- Richard Pickwick proposed that the Board authorize the purchase of a patio seating set, as explained in the attached email. After discussion, no motion was made and the matter died for lack of a motion.
